RESOLUTION FOR BOARD TO ADOPT:

RESOLVED, that the School Board of Independent School District 271 approves the First Amendment to the existing Research Agreement with the City of Bloomington, acting through the Public Health Division. The term of the Research Agreement is from January 1, 2016 until December 31, 2020.

DETAILED BACKGROUND:

The City has data needed by the Executive Director of Research, Evaluation, and Assessment for early childhood program research. The Research Agreement enables the District to work collaboratively with the City to determine how to provide better early childhood services. The original Research Agreement was dated March 14, 2016. This First Amendment extends the Agreement until December 31, 2020. This Amendment was approved by action of the City Council on October 1, 2018.

The District's legal counsel and insurance agent of record have reviewed the agreement.

**FIRST AMENDMENT
TO THE EXISTING RESEARCH AGREEMENT BETWEEN

This First Amendment to the existing Research Agreement dated March 14, 2016 between Independent School District No. 271 (District), 1350 W. 106th Street, Bloomington, MN 55431 and the City of Bloomington (City), a Minnesota municipal corporation, acting through its Public Health Division, 1800 Old Shakopee Road, Bloomington, MN 55431 shall be effective as of January 1, 2019.

WHEREAS, the District and the City wish to extend the term of the Research Agreement dated March 14, 2016;

IT IS THEREFORE AGREED:

1. That all terms of the Research Agreement shall continue to be in effect and binding on the parties, except that which is hereto specifically changed or amended.


2. Subdivision I. Term of Agreement shall be deleted, and in its place shall be:

I. Term of Agreement

The term of this Agreement shall be from January 1, 2016 until December 31, 2020, subject to termination as provided in Subdivision V. The term of this Agreement shall enable the District to work collaboratively with the City to determine how to provide better early childhood services.
